INTRODUCTION:

Madhya Pradesh State Tourism Development Corporation Limited also referred to as the “MPSTDC” or “Authority”, is a nodal agency under Department of Tourism, Government of Madhya Pradesh (“DoT”) with a mandate to develop tourism infrastructure in the State of Madhya Pradesh. MPSTDC is also operating various hotels and tourist complexes in the State for providing boarding & lodging facilities to the tourists.

MPSTDC intends to empanel consultants who can provide its advisory services for preparation and conceptualization of various projects in tourism sector.

MPSTDC shall endeavor to adhere to the following schedule:

MPSTDC MAY TAKE THE FOLLOWING TYPE OF PROJECTS:

1. Development/improvement of new/existing infrastructure.
2. Projects related to tourist facilities and tourist facilitation.
3. Publicity and Promotion.
4. Capacity building.
5. PPP Projects.
6. Survey and market research.
7. Overseeing project implementation.
8. Any other tourism projects.

MPSTDC proposes to have a panel of tourism consultant **for a duration of three years** whose services can be utilized as per the brief scope of work indicate below:

ELIGIBILITY CRITERIA:

1. The consultant must be of National Repute and have reasonable office set up in Madhya Pradesh, preferably at Bhopal/Indore.
2. The consultant should have experience of atleast 03 (three) years in Government/Government Organizations in the area of development of infrastructure projects.
3. Preference shall be given for the experience of tourism projects with Government/ Government organizations/Private sectors.
4. The consultant should have minimum annual turnover of Rs. 20.00 lac in the last financial year ending 31/03/2014.
5. Relevant documents in support of these eligibility criteria should be submitted

with the document.

GENERAL INSTRUCTIONS TO APPLICANTS:

- Intending applicants are required to submit their **details** about their organization, experience, technical personnel's in their organization, spare capacity, proven competence to handle major works, in house computer aided design facilities etc in the enclosed Performa
- As the time is essence of a contract, the **ability and the competence of the applicant to render required services within the specific time frame**, will be a major factor while deciding the selection of Tourism consultants.
- The application shall be signed by the person/s on behalf of the organization having necessary authorization / **power of attorney** to do so. Each page of the application shall be signed (copy of power of attorney shall be furnished along with the application)
- In case of completed projects, Applicant shall submit work orders & completion certificate from client, while for projects in hand; Applicant shall submit work orders from respective client with Government Department / Government Organization / Private Tourism Projects.
- The Applicant should **have qualified professionals and technically sound people on board**. It is one of the very important selection criteria from their organization. Please submit the details of technical staff and associated consultant as per Performa.
- **The turnover of the firm that qualifies shall have to be from consultancy services only and not allied services for which necessary documents should be furnished.**
