1. **Tender Fee:** Separate D.D. of ₹ 1,000/- in favor of **M.P. State Tourism Development Corporation Ltd. Bhopal** to be enclosed with the tender. Tender fee is non-refundable.
2. **Earnest Money Deposit:** Separate Bank Draft of ₹ 10,000/- in favor of **M.P. State Tourism Development Corporation Ltd. Bhopal** as EMD is essentially required with the tender otherwise, tender will not be entertained. The EMD will be kept with us for a period of One Year. EMD of Disqualified tenderer will be returned after 45 days from the date of finalization of the tender.
