**For design, manufacture, supply and commissioning Cruise boat cum Floating  
Restaurant at MPT Boat Club, Pipliyapala Regional Park, Indore M.PI**

**Concept:** It is proposed to launch Cruise Boat cum Floating restaurant having a capacity of around 80 passengers plus crew of 15. The Floating Restaurant should have an air-conditioned restaurant on the lower deck. The upper deck should be open with only a canopy and serve as open air restaraunt.

2) **Scope of Work:** Design, manufacture, interior, furnishing' supply and commissioning (at site) of cruise boat cum floating restaurant for Pipliyapala lake at Regional Park Indore to the following general requirements and specifications.

- The Cruise boat cum Floating Restaurant, hereinafter referred as Boat, should be built utilizing modern technology and the advanced materials/equipment available.
- The Boat should meet all IRS and MMD specifications for safety norms.
- The boat should have state of art interiors and an aesthetic colour scheme for its super structure.
- The boat should not pollute the lake in any manner by way of discharge of effluents, sewerage and waste. The noise level has to be minimal and should be indicated in decibels both for the lower and upper decks. The boat should have a simple arrangement for storage of the discharge and wastages which could then be removed ashore.
- Capacity : 80 passengers + 15 crew.
- Draft : 0.80 to 1.0 m at max load
- Type of Boat : Twin Decks, catamaran hull, FRP Hull
- Lower Deck : AC Restaurant (approx 50 covers) with pantry, store, kitchen and 2 toilets. The furniture for the restaurant, Bar counter.
- Upper Deck: Viewers deck with semi foldable canopy. Seating arrangement for about 30 covers. Strong SS railing all round. Stage for cultural performance. Front mounted bridge.
- 25 KVA Genset
- 75 HP twin OBM Mounted astern and RC from Bridge
- Interiors: Interiors and seating arrangements in Restaurant etc. to be done in consultation with Advisor (ETA) of the Corporation.
- Bridge (Air conditioned): Most modern design with digital control panel, Echo Sounder, Compass, Fresh Water and Fuel meters (Digital), Speedo meter, Navigational aids and other instruments considered essential.
- Nav-Lights: All Navigational lights.

- Mast: A suitable designed aluminum Mast with Nav-Lights and Yardarm for flags pulleys, radio aerial etc.
- Fresh Water capacity: 1000 Liters.
- Construction : The Hull and the Boat should be constructed of High Grade FRP as per IRS specifications
- Anchors: Two bow anchors and one astern anchor with motor winches.
- Arrangement for disposal of discharge: Arrangement for waste disposal by pumping ashore into the containers for transporting and disposing away from the lake.
- Toilets 2 No.
- Specified number of Life Buoys, Life Jackets.
- Fenders: As per MMD specifications. Lines for securing along side.
- **Mooring Buoy: Boat should be Moored to a Mooring Buoy with a swing circle of 30 to 40 m. While moored Boat should be able to withstand a wind gale and storm with a high speed wind (upto a gust of 50 knote)**
- The commissioning and Mooring shall be responsibility of the builder.

3) **Procedure for submission of Bids:** This is a two packet bidding process.

The main envelope should contain two envelopes, one each for the technical and financial bids. Earnest Money of Rs 50,000/- (fifty thousand only) by way of Demand Draft favouring MPSTDC payable at Bhopal should also be placed inside the main envelope along with the envelopes for technical and financial bids, not inside any of the two bid envelopes.

- The two envelopes for technical and financial bids should be properly super scribed as indicated below.

- All the 3 envelopes should be sealed in wax.
- The Technical Bid shall contain the following :

Full details of the company including turnover, personnel, registered address, head-office address, works address, name/designation/phone number and other details of the contact person etc.

Specific confirmation or otherwise and relevant technical details against all items indicated Para 2 above. Material specifications of all relevant items be also furnished. Reasons for deviation, if any should also be indicated.

Specific confirmation or otherwise against all items indicated in Para 4 below. Reasons for deviation if any should also be indicated.

Credentials – Details of all orders executed so far.

Copy of Valid ITCC

Copy of Valid IRS or equivalent certificate.

Delivery Period

- The Financial Bid shall contain the following

Price of optional items as indicated in para 2 above.

Payment Terms

- The total price shall be firm and there should not be any hidden costs whatsoever in the same.

#### 4. Other Terms and conditions

a) Only Manufacturer who have build minimum 3 Cruise Boats as per the above or superior specifications which are in operation are eligible to bid. They must submit the proof for the same.

b) Earnest Money: The main envelope should contain earnest money as indicated in para 3 above. Offers submitted without earnest money shall be summarily rejected.

b) Warranty: One year against all manufacturing defects. Performance Guarantee of 5% of the contractual amount valid for one year will be retained by MP Tourism.

c) Payment Terms: Full payment against each boat cum floating restaurant shall be released within 30 days of successful commissioning. However in case if the bidders prefer different payment terms, the same should be indicated in the price bid.

d) Inspection: Following mandatory stage inspections shall be carried out by the authorized representative of Madhya Pradesh Tourism.

- After completion of Hull.
- After laying of Decks and fabrication of Super structure.
- Inspection of all machineries and equipment after it is received and before installation.
- During Interiors and finishing.
- Any time during construction.

e) Documentation including complete design details, line plans and original guarantee cards of the equipment fitted on board should be supplied along with the Boats.

f) Delivery Period: Delivery period of the boat should be indicated. **An early delivery period shall be preferred.** In case of delayed supplies, a penalty @ 0.5% of the contractual value per month maximum upto 5% of contract value shall be levied and deducted from the bills of the supplier. The corporation also reserves the right to cancel the contract and recover advance payments made if any in case of delayed supplies besides carrying out risk purchase at the risk and cost of the supplier. Force majeure class shall be applicable.

g) Disputes: In case of any dispute, the decision of the Managing Director, Madhya Pradesh State Tourism Development Corporation shall be final and binding.

h) Any offer not in line with the conditions stipulated in this tender document can be summarily rejected

i) The offers should be valid for at least 6 months.

j) The bidders should be prepared to make a presentation at short notice at MPSTDC HQ Bhopal.

k) Force Majeure clause shall be applicable.

l) MPSTDC reserves the right to reject any Bid if:

- (a) at any time, a material misrepresentation is made or uncovered, or
- (b) the Bidder does not respond promptly and thoroughly to requests for supplementary information required for the evaluation of the Bid

The above would lead to the disqualification of the Bidder. If such disqualification / rejection occur after the Commercial Bids have been opened and the Bidder with Lowest bid gets disqualified / rejected, then MPSTDC reserves the right to:

- a. declare the Bidder quoting the Second Lowest Commercial Bid as the successful bidder and where warranted, invite such Bidder to equal the Commercial Bid of the disqualified Bidder;
- OR
- b. take any such measure as may be deemed fit in the sole discretion of MPSTDC, including annulment of the Bidding process.

**m) EVALUATION OF BID:**

Company will take the total Price of the equipments for arriving at L-1 Price. Total price of the equipments is inclusive of all Tax/levies/duties as applicable. The Evaluation of the Technical Bids the Technical Evaluation Committee giving weightage to following factors:

- a. Safety of the user shall be most important and all water borne equipment shall have minimum 100% safety factor.
- b. The safe bouncy, water tight integrity and anti rust sustainability shall be optimum.
- c. The ease of operation and comforts to the user shall have due consideration.
- d. The firms manufacturing the equipments and quoting themselves for those items will be given preference.
- e. The technical specifications vis-à-vis safety and operational capabilities will play decisive role for finalizing the order.
- f. **In case of imported items the bid should mention the exchange rate at which quote has been made. The difference will be either paid or deducted from the total amount on date of supply of material depending upon the existing foreign exchange rates. The tax will be on actual which have to be mentioned in bid and the transportation will be paid on actual with the support of consignment bills to the various destinations where items are supplied. Transit Insurance will be born by the firm.**

**n) Opening of Financial Bids**

- The Financial Bids of all the Bidders who are technically qualified shall be opened in the presence of the Bidders' representatives who choose to attend. The Bidders' representatives who are present shall be required to sign and record their attendance.

- The Bidder Quoting the lowest Bid may be declared the successful bidder.
- In the event that two or more Bidders quote the same Bid, MPSTDC may:
  - a. invite fresh Bids from the Bidders;
  - OR
  - b. take any such measure as may be deemed fit in its sole discretion, including annulment of the Bidding process.

**O) No commitment to Accept Lowest**

MPSTDC shall be under no obligation to accept the lowest or any other offer received in response to this notice and shall be entitled to reject any or all offers without assigning any reason whatsoever, any time during the process.
