Managing Director MPSTDC invites sealed tenders from reputed firms/authorized distributors and dealers having valid TIN & PAN Nos. for **Annual Rate Contract to SUPPLY OF BONE CHINA CROCKERY** for their hotels under the Terms & conditions given below: -

1. **Tender Fee:** Separate D.D. of Rs. 1,000/- in favor of **M.P. State Tourism Development Corporation Ltd. Bhopal** to be enclosed with the tender. Tender fee is non-refundable.
2. **Earnest Money Deposit:** Separate Bank Draft of Rs. 25,000/- in favor of **M.P. State Tourism Development Corporation Ltd. Bhopal** as EMD is essentially required with the tender otherwise, tender will not be entertained. The EMD will be kept with us for a period of One Year. EMD of Disqualified tenderer will be returned after 45 days from the date of finalization of the tender.
3. **Specification:** Tenderers are advised to submit their tender with complete specifications of their products along with samples & relevant literatures. Without samples, tender will not be considered.
4. **Price Bid:** The prices of products are written in figures legibly. Any corrections are duly signed before submitting the tender. No correction will be entertained after opening the Tender. Rates are required according to the rate schedule as per **Annexure-A**.
5. **Discount:** Percentage of discount to be specified separately and the same will be valid for a period of one year.
6. **Terms of Payment:** Payment will be released against satisfactory delivery of the goods at our respective destinations. Delivery reports duly signed by authorized person in the respective units/offices are to be attached along with the Invoice for processing of payment.
7. **Warranty/Guarantee:** Supplied items to be warranted for the quality for One Year. CROCKERY items with cracks, granuals on surface, manufacturing defects and breakage would not be accepted. During usage of the Crockery if found spots on the surface, this will have to be replaced within One Year on supplier's cost.
8. The rate approved by M.P.T. officials against this tender will be valid for a period of minimum 12 months and may be extended for another One Year on mutual consent. Any statutory variation during the time of finalization will be adjusted accordingly.

9. **In case of failure of delivery or refusal of the Purchase Order under the terms and conditions mentioned in the tender document, Earnest Money will be forfeited and rates of the second lowest party would be considered.**
